Clerk Treasurer Angela Hamrick read by title only and numbered R-25-19. A Resolution to Transfer City Funds Between Accounts for the Year 2025.



Ayes: Jeff Turner, Craig Dellinger, Mike Mowery and Bob Byrd.


Nayes: None
