DROP OFF

SPECIFICATIONS

- All unwanted RESIDENTIAL trash will be inspected before it is accepted for disposal.
- Only pick-up truck size loads or smaller will be accepted.
- One (1) drop off load per household will be accepted.
- Appliances that utilize Freon **MUST** have a certificate of Freon removal before they will be accepted.

This is offered to New Haven residents. In order to provide this service on an annual basis, we will evaluate the response and participation each year and possibly lift certain restrictions in the future. Earth First will provide dumpsters as well as the disposal of unwanted residential trash and waste collection. This service is **FREE** to New Haven residents, therefore, we strongly encourage you to participate by bringing your unwanted items to the location listed above.

SENIOR CITIZENS

In addition, this year the City of New Haven would like to offer pick up service for our senior citizens who are unable to utilize the drop off site. FINE SCHEDULE FOR THE CITY CODE OF NEW HAVEN DEALING WITH SEWERS AND SEWAGE SYSTEMS



The New Haven Board of Public Works and Safety established a fine schedule for Ordinance G-17-04 (Chapter 51) and City Council approved the fine schedule at its most recent meeting. All residents are required to comply with the Ordinance. Any residents or commercial services who still have illegal connections can be fined in the amounts listed below.



§51.10	Permit Inspection Fee for Private Sewage Disposal Systems.	\$25.00
§51.12	Discharge of Unpolluted Water from Air Conditioners, Cooling and Condensing Systems (commercial and industrial customers only).	\$10.00 per 10,000 s.f.

SUMMER WASTE WATER DISCOUNT

Customers typically use the most water during the summer months; therefore, all residential customers inside the city limits are automatically put on a discounted wastewater rate for the summer. This discount allows customers to use more water while paying less wastewater.

Each customer's discount is unique to their own usage average for the previous months of December, January, February and March. This average becomes the wastewater cap for any water used over and above their average during the summer discount timeframe from **(May 10, 2018 - September 6, 2018)**. Ex: Customer "A" has an average of 5,000 gallons of water from Dec-Mar. June's water usage is 8,500 gallons but they are only charged for 5,000 gallons of wastewater. They are getting a discount of 3,500 gallons on their waste water portion of their bill. For questions, please contact the New Haven Utility Office at 748-7050.

Public Hearing on Water Rate Increase

New Haven City Council Meeting

April 24, 2018 at 7:00 p.m.

How the rates are passed?

The rates are passed through a City Ordinance. To pass an ordinance, it has to go through three “readings”. If an ordinance has a direct financial impact on residents, it also requires a public hearing. The public hearing for this water rate increase will be held on Tuesday, April 24, 2018 at 7:00 p.m. in the City Council Chambers at City Hall.

How will this affect my bill?

If you want to figure your water rate increase quickly, simply look at the “water” portion only of your bill and add 25% to see how this will affect you. Below is a breakdown of costs that illustrate how a rate increase would affect a bill for an average residence.

Sample residential cost

Example: A household that used 2,300 gallons of water in a month currently has a bill of \$17.92 for water, \$1.25 sales tax, \$53.75 for sewer, and \$5.35 for storm water. That's a total of \$78.27. When you figure a 25% increase on water, it will increase this household's monthly bill approximately \$4.43. Please keep in mind that this is just a sample as every household is different.

Why aren't there small increases annually?

In order to cover increases and keep our water utility sustainable, the City's financial consultant recommended a 50% increase back in 2016. After much discussion, city officials felt that a 50% increase was much too large of an amount to pass on to residents all at one time. Therefore, the recommended increase was divided into two different segments to keep the cost more affordable. A 30% water rate increase took effect in April of 2017, and an additional 25% water rate increase would take effect in early 2018. After this current 25% water increase, the City plans to review water and sewer rates annually to keep up with increases passed on from Fort Wayne.

Breakdown of your water bill.

There are 3 different components that make up a utility bill. There is a water rate, a sewer rate and storm water rate.

Will water and sewer increases ever end?

That's a very good question and unfortunately, there isn't much good news. Water/sewer costs in general are going to continue to increase. In addition to the increases in wholesale water and sewer rates from Fort Wayne, the Indiana Department of Environmental Management (IDEM) requires us to meet standards for waste treatment and eliminating discharges into the rivers. We don't think water rates will increase greatly over the next few years; however, sewage rates are going to be a problem. Fort Wayne is just starting their sewer separation project and we've heard estimates from \$500 million to a billion dollars that they'll need to satisfy IDEM requirements. That cost is going to eventually fall on their users.

What else can we do?

Conservation is perhaps the most important step you can take to keeping your monthly water bill low. Among the things you can do: fix leaking faucets and toilets that run; use reduced-water showerheads; where practical convert to water saving, high efficiency toilets, washers and dishwashers; eliminate water run-on when washing hands and dishes. In other words, the less water you use, the lower your total bill will be. We will continue to search for efficiencies that the City can do to reduce costs. We're proud of our people and the work they do, but we have to figure out how to make cuts.
