2. Approval of Minutes

Bruce Bestul made a motion to approve the April 1, 2024, minutes. Randy Price seconded. Motion carried.

3. Approval of Claims

NEW BUSINESS:

- Fees Discussion: As the Directors report states, we are going to have to postpone the credit card fee process for this season, but Nick would like to lower the minimum to \$5.00 for the credit card charge at Jury pool. See more as stated in the Director report as attached in minutes. Bruce Bestul made a motion to amend the credit card fees at Jury Pool to a \$5.00 minimum. Randy Price seconded the motion.

- Director Goranson passed out a new menu put together by the Concession Manager with fees for the Park Board to look at and get approval for this year. Bruce Bestul made a motion to approve the concession fees for 2024. Randy Price seconded the motion.
- Marylands Farm Park Grant Discussion: Director Goranson presented two bids on the first phase of the parking lot installed. We received bids from Fleming for \$38,202.00 and Fritch's \$32,826.00. This contract needs to be done before June 1<sup>st</sup> for the grant to be able to use. Nick will send it to Sarah Nichter tonight to get it into motion. Bruce Bestul made a motion to accept the bid from Fritch's for subbase for \$32,826.00. Randy Price seconded the motion.
- Rec Department Restructure Discussion: Abby Tucker resigned her position as Enrichment Program Coordinator and Sue Grossnickle retired. And now we are looking to restructure the Rec Department. More discussion followed. And there is more listed in the Directors report that is attached to the minutes. After much discussion of the restructuring, Randy Price made a motion to approve numbers 1-4 in the Directors Report on page #2. This includes Angela Daniel as part-time Rec. Director at \$20.00 per hour. And to create two part time positions, Senior Lifestyle Coordinator at \$15.00 per hour and a part time Rental Custodian at \$20.00 per hour. And a seasonal position for a playground director at \$15.00 per hour. (These can all be found in the Directors report as well.) Bruce Bestul seconded the motion.
- Approval of the Seasonal Hires: Natalie Rider presented 6 pages of Seasonal Hires with names, positions, and wages for 2024 hires so for around 60 staff have been hired. Bruce Bestul made a motion to approve 2024 Seasonal hires. Randy Price seconded the motion.

- Still working on the Jury pool liner. It is less creased. The company that installed it couldn't come back until August to work on it, so we decided to do it ourselves.
